- 4. The objects for which the corporation is incorporated are: Objets pour lesquels la personne morale est constituée:
 - 1. To promote education, research and dialogue of all religions and in the spiritual heritage of humankind on the Internet.
 - 2. To organize, promote, and provide down-loadable material, dialogues, chat and discussion sessions, and the like in a focussed and disciplined manner with respect to spirituality and religion.
 - To provide a library of spiritual heritage literature including Commentaries and interpretations of heritage literature in English and other popular languages, publications, novels, plays, stories, and anecdotes based on truth or fiction exemplifying spiritual principles in life for scholars and research workers at universities, research centres, and institutions of higher learning.
 - 4. To host public essay competitions from youth to promote spiritual living and spiritual development;
 - 5. To provide syllabi and educational material for courses on spiritual and ethical education in primary schools, high schools, colleges, and universities.
 - 6. To deliver courses on spirituality and ethics at different levels on the Internet in distance education mode.
 - 7. To receive and maintain a fund or funds and to apply all or part of the principal and income therefrom, from time to time, for charitable organizations, and in particular for charitable organizations or purposes as follows:
 - (a) to provide bursaries and scholarships to deserving students in accordance with the Corporation's policies and practices governing such disbursements; and
 - (b) to institute Chairs at universities to promote education in spirituality.

5. The special provisions are/Dispositions particulières:

The corporation shall be carried on without the purpose of gain for its members, and any profits or other accretions to the corporation shall be used in promoting its objects.

Statutory Powers

(i) For the above objects, and as incidental and ancillary thereto, to exercise any of the powers as prescribed by the *Corporations Act*, or by any other statutes or laws from time to time applicable, except where such power is limited by these letters patent or the statute or common law relating to charities including:

Power to Receive Material

(ii) To receive material from volunteer contributors world wide with respect to all religions and spiritual heritage and to direct it through an editorial process before acceptance for publication on the Internet.

Power to Provide Material

(iii) To provide audio, video and other material illustrating spiritual principles and ethical conduct in life related to business, commerce, scientific, and technological activities;

Power to Accumulate

(iv) To accumulate from time to time part of the fund or funds of the corporation and income therefrom subject to any statutes or laws from time to time applicable;

Power to Invest

(v) To invest the funds of the corporation in such manner as determined by the directors, and in making such investments the Directors shall not be subject to the *Trustee Act*, but provided that such investments are reasonable, prudent and sagacious under the circumstances and do not constitute, either directly or indirectly, a conflict of interest;

Power to Solicit Donations and Grants

(vi) To solicit and receive donations, bequests, legacies and grants, and to enter into agreements, contracts and undertakings incidental thereto;

Power to Receive Personal Property

(vii) To acquire by purchase, contract, donation, legacy, gift, grant, bequest or otherwise, any personal property and to enter into and carry out any agreements, contracts or undertakings incidental thereto, and to sell, dispose of and convey the same, or any part thereof, as may be considered advisable;

Power to Hold and Dispose of Real Property

(viii) To acquire by purchase, lease, devise, gift or otherwise, real property, and to hold such real property or interest therein necessary for the actual use and occupation of the corporation or for carrying on its charitable undertaking, and, when no longer so necessary, to sell, dispose of and convey the same or any part thereof;

Power to Hire

(ix) To employ and pay such assistants, clerks, agents, representatives and employees, and to procure, equip and maintain such offices and other facilities and to incur such reasonable expenses, as may be necessary, provided that the corporation shall not pay any remuneration to a Director in any capacity whatsoever;

Power to Cooperate with any Other Organizations

(x) To cooperate, liaise, and contract with other organizations, institutions or agencies which carry on similar objects to that of the corporation;

Power to Participate in the Reorganization of a Company

(xi) To take up proportions of any increased capital of a company or corporation in which the corporation may at any time hold shares or obligations; to purchase any additional shares or obligations in such company or corporation; to join in any plan for the reconstruction or reorganization or for the sale of assets of any company or corporation, or part thereof; to enter into any pooling or other agreement in connection with the shares or obligations of a company or corporation held by the corporation; and to give consent to the creation of any mortgage, lien or indebtedness of any company or corporation whose shares or obligations are held by the corporation provided, however, that all of the foregoing is subject to the provisions of the *Charitable Gifts Act*;

Power to Sue and Compromise Claims

(xii) To demand and compel payment of all sums of money and claims to any real or personal property in which the corporation may have an interest and to compromise any such claims, and generally to sue and be sued in its corporate name;

Power to Issue Cheques

(xiii) To draw, make, accept, endorse, execute and issue cheques and other negotiable or transferable instruments;

Power to Pay Costs of Incorporation

(xiv) To pay all costs and expenses of, or incidental to, the incorporation.

No Gain for Members

(xv) The corporation shall be carried on without the purpose of gain for its members and any profits or other accretions to the corporation shall be used in promoting its objects.

Charities Accounting Act and Charitable Gifts Act

- (xvi) The corporation shall be subject to the *Charities Accounting Act* and the *Charitable Gifts Act*.
- (xvii) If it is made to appear to the satisfaction of the Minister, upon report of the Public Guardian and Trustee, that the corporation has failed to comply with any of the provisions of the *Charities Accounting Act* or the *Charitable Gifts Act*, the Minister may authorize an inquiry for the purpose of determining whether or not there is sufficient case for the Lieutenant Governor to make an Order under subsection 317(1) of the *Corporations Act* to cancel the Letters Patent of the corporation and declare it to be dissolved.

Borrowing Power

(xviii) The borrowing power of the corporation pursuant to any by-law passed and confirmed in accordance with section 59 of the *Corporations Act* shall be limited to borrowing money for current operating expenses, provided that the borrowing power of the corporation shall not be so limited if it borrows on the security of real or personal property.

Distribution upon Dissolution

(xix) Upon the dissolution of the Corporation and after the payment of all debts and liabilities, the remaining property of the Corporation shall be distributed or disposed of to charitable organizations which carry on their work solely in Ontario.

Power to Promote Unity in Diversity

(xx) To promote the spiritual concept of "unity in diversity".


